### An Act to Approve the Nominations to the WSBA Budget and Finance Committee for 2022-2023

*Background:*

The Washburn Student Bar Association (WSBA) annually delegates the task of developing a budget to the WSBA Budget and Finance Committee. Such delegation is governed by WSBA Bylaw 101. The WSBA Budget and Finance Committee consists of: (1) the WSBA Vice President, (2) the WSBA Treasurer, (3) three members of the WSBA Governing Body, and (4) four members of non-members of the WSBA Governing Body. WSBA Bylaw 101, §II provides that the WSBA Vice President shall nominate the members not named by title to the WSBA Budget and Finance Committee. These nominees must be approved by a majority vote of the WSBA Governing Body. The Bylaws also require the WSBA Vice President to make a "concerted effort" to "select a diversified cross-section of the student body." The WSBA Vice President is exercising their nomination authority and requests the approval of the WSBA Governing Body.

This bill seeks to approve the nominations to the 2022-2023 WSBA Budget and Finance Committee.



## **AN ACT**

**Section 1.** The Washburn Student Bar Association (WSBA) shall hereby approve the following nominations of the WSBA Vice President to the WSBA Budget and Finance Committee for 2022-2023:

- (a) Nathan Seltzer, At-Large Representative;
- (b) Angelique Brown, Barrister's Ball Coordinator;
- (c) Mika Schmelzle, 1A Representative;
- (d) Andrew Foreman;
- (e) Ginta Bickerstaff;
- (f) Audrey Mackey;
- (g) Alyssa Crenshaw.

**Section 2.** The Term for individuals nominated and approved through Section 1 of this Act to serve on the WSBA Budget and Finance Committee shall commence immediately upon passage of this Act and shall cease immediately upon adoption of a 2022-2023 WSBA Budget by the WSBA Governing Body.

**Section 3.** Any WSBA law, policy, procedure, rule, or regulation, in whole or in part, in conflict with this Act shall be hereby repealed.

**Section 4.** This Act shall become effective immediately upon passage.
